IPAD AGREEMENT -WAYNE HIGH SCHOOL-

An addendum to the Wayne School District ipad Policy and Agreement

District Policy and Agreement

The Student and the Student's Parent/Guardian must read, agree to, sign, and return the Wayne School District Acceptable Use Policy and iPad agreement before an iPad will be issued. This can be done on Aspire or the WHS Acceptable Use Policy and Ipad Agreement is on the high school website (https://www.waynesd.org/whs-home.html) under students then WHS Handbook and Policies.

Fees

The annual fee for the student iPad is \$10 and must be received by the office BEFORE an iPad will be issued.

Clarification

IPads are the PROPERTY OF WAYNE SCHOOL DISTRICT and can be confiscated by school faculty at any time for ANY reason.

Inappropriate Use

Administration and faculty maintain the right to determine, and adjust, what does and what does not constitute inappropriate use of iPads at Wayne High School. These expectations of inappropriate use will be communicated clearly to the students of Wayne High School. In addition, each teacher will communicate clearly to his or her students what constitutes inappropriate use in his or her classroom.

Consequences of Inappropriate Use

- 1. <u>First offense</u>-- Warning will be given, all non-educational or inappropriate apps and content will be deleted along with accompanying data.
- Second offense--All non-educational or inappropriate apps and content will be deleted along with accompanying data. The student will need to pick up their ipad in the office before school starts and drop off in the office after school is out. This procedure will last to the end of the quarter.
- 3. <u>Third offense</u>--All non-educational or inappropriate apps and content will be deleted along with accompanying data. The student will need to pick up their ipad in the office before school starts and drop off in the office after school is out. This procedure will last to the end of the year.

4. Remember the above clarification that faculty/staff can confiscate ipads (school property) at ANY time for ANY reason.

Unattended iPads

As per the security section of the Wayne District Policy, students are required to never leave their iPads "unattended or unsecure". Unattended/Unsecure iPads will be confiscated, turned in the office, and a \$5 fee will be assessed to the student's account.

Broken/Negligent Use

- 1. 1st Offense-ipad will be fixed at no charge to the student if considered an accident.
- 2. 2nd Offense-student will pay the cost to repair the ipad, charger, or case, etc (typically \$35 for screen only). If cost is higher, then student/parent/guardian shall pay the higher fee up to \$150.
- 3. 3rd Offense-iPad is taken away. Student shall be only allowed to use classroom iPad. Original iPad can be reissued once the ipad repairs are paid for by the student.
- 4. NOTE: **If ipad is lost or returned in an unrepairable state**-Flat fee of \$150 and instructions as per 3rd Offense.
