The Superintendent shall report any interim appointment(s) to the Board and ensure appropriate financial oversight during the transition period."

#### • Motion 3:

## Motion made by Jim, seconded by Curtis. Motion passed unanimously.

"I move that the Wayne School District Board of Education, in collaboration with the Superintendent, initiate the process of hiring a new permanent Business Administrator by utilizing the services of the Utah School Boards Association (USBA) for recruitment and selection. The Superintendent is authorized to work with USBA to develop a candidate profile, advertise the position, and facilitate the hiring process, with regular updates provided to the Board."
